### Winner Daisy

**The judges said:** Daisy has shown that it can protect services on premise, in the public or private cloud, protect and recover legacy technology – even for the most critical business functions – and deliver integrated services that meet all of a customer’s specific RPOs and RTOs across their business.

**About:** Digital businesses need constant engagement with their customers. It is no longer tolerable for application services to be down. While it may cause no significant damage to be down for a short while, businesses increasingly demand ‘always-on’ availability. Daisy’s scalability and flexibility means it can protect services on premise – in the public or private cloud, or a combination of the two. It is able to protect and recover legacy technology, helping to deliver integrated availability services for complex hybrid environments that meet even the most demanding RPOs and RTOs. Then Daisy is able to recover them on premise, to private or public clouds, into its business continuity infrastructure of 18 business continuity centres or via its mobile fleet to any location throughout the UK. Daisy’s cloud and virtual platforms mean it can scale from the smallest business to the largest enterprise. Its largest customer has data volumes of 100TBs with 300 servers across


mixed Microsoft and UNIX estates; its smallest has four servers and 350GB on Microsoft Windows. “Taking this award is a real achievement for Daisy and it clearly shows that our current offering delivers assurance and secure data recovery for our customers today,” said Availability Services Director at Daisy, Andy Dunn. “Our experience and capability provides a perfect foundation for development of new solutions in the ever changing data availability and recovery markets. ## Resilient Workforce Award

### Winner Medical Research Council

**The judges said:** This organisation's experience following the Ebola Crisis, Basse Floods and most recently the post electoral crisis in the Gambia taught its staff valuable lessons, informed plans with guiding principles and priorities, trigger points, teams and communication lines and encouraged discussion, and scenario testing.

**About:** The Medical Research Council's research unit in The Gambia (MRCG) is the Council's single largest investment in medical research in a low and middle income country. MRCG represents a unique concentration of scientific expertise and high quality research platforms in the West African region. Its research portfolio spans basic research to the evaluation of interventions for the control of diseases of public health importance in sub-Saharan Africa. MRCG's scientific vision is to contribute to the post-2015 sustainable development agenda by producing the evidence base to improve health in West Africa and beyond.

The 2016 Gambia Presidential Elections were held on December 1st 2016. For three days during the voting process and the broadcast of the results internet and international phone communications were interrupted by the government.

The Gambian electorate chose the opposition leader Mr Barrow by a margin of 21,000 votes. The incumbent, President Jammeh, did not accept the outcome of the elections claiming electoral irregularities. The rejection of the election results by Jammeh was followed by increased presence of Gambian soldiers in the streets and by the occupation of the offices of the Independent Electoral Commission by the Gambian Army.

On January 17th Jammeh declared a state of emergency, and ECOWAS troops entered the country two days later. MRCG continued to support and contribute to the Gambian health services. Jammeh left the country on Saturday 21st January, two days after his expected passage of power to Barrow. MRCG returned to normal activities on 24th January. As part of its resilience planning, MRCG has a well trained business continuity team that has proven its value during crises over the last two to three years.

This year's new award was presented to this organisation for recognising its most important asset: its people. The judging panel was impressed by how communication and scenario based training formed part of MRCG's commitment to both safeguarding its workforce and using this vital asset.
