Winner Dr Chapman and Associates

The judges: The highly competitive Risk Management Innovation category reflects the huge potential for fresh thinking within the profession. Dr Chapman and Associates' work on project risk maturity models is a shining example of the need for such thinking in the vital arena of cyber risk management.

The winning entry: Dr Chapman and Associates is a boutique management consultancy specialising in project, programme and enterprise risk management services in the project arena. Founder and managing director, Dr Robert Chapman has over 30 years' experience in delivering risk management services to such companies as National Grid, Network Rail, British Airways, Thames Water, Pfizer, BBC Broadcast, AstraZeneca, Transport for London, Guinness Ltd and National Highways.

Following a government report that warned the UK was not prepared to cope with the serious threat of coordinated ransomware attacks (despite being one of the most targeted countries in the world), the consultancy has focused increasingly on the embedding of cyber security within projects. The report focused specifically on the anticipated degree of resilience of the UK's critical national infrastructure against ransomware.

The latest National Cyber Security Centre Annual Review described the threat to CNI as "enduring and significant". In this winning entry, DCA outlined an enhancement of project risk management maturity models to incorporate an assessment of cyber resilience within the project lifecycle of CNI projects, to reduce their vulnerability during operations.

Dr Chapman highlighted: "Protection of our national infrastructure is vital; we depend on our CNI from the time we get up in the morning to the time we retire for the night. We rely on it for such things as drinking water, energy, transport, the internet and mobile phone networks. A coordinated cyber attack could leave part of the UK with no electricity supply, internet, mobile phone connectivity or contactless payment options.

"For cyber resilience to be effective it needs to be embedded throughout a project's lifecycle including all phases and gates (go/ no go decision points). Based on its knowledge of large infrastructure projects, DCA has been well paced to support this integration. In particular, the work of DCA has been to highlight the need to protect our CNI through a number of papers – and in particular to support the embedding of cyber resilience throughout the design phases of energy projects to minimise vulnerabilities when completed projects are integrated into operations. The work is ongoing as the risk landscape is moving at a staggering pace and the attacks by malign actors are unrelenting."


